


Privacy Notice

1. Introduction

This privacy notice covers the use of QLog Technologies Ltd (QLog) products in the United Kingdom (UK) and the European Union (EU) countries.

The processing of your personal data is carried out by QLog under the framework provided by the General Data Protection Regulation 2016/679 EU GDPR, the UK General Data Protection Regulation UK GDPR and the UK Data Protection Act 2018.

QLog is registered in Israel under company registration number 515699858 and our registered office is located at Ha-Melacha St 6, Binyamina, Israel. For the purposes of applicable data protection legislation QLog is the data controller for the personal data we process, as described in this privacy notice unless otherwise stated.

This privacy notice tells you what you can expect from us with regards to the collecting, storing and use of your information. It explains in detail:

- the purposes we are processing your information for and why we are lawfully allowed to do this;
- where we gain your information from and whether there are other recipients of your personal information;
- whether we intend to transfer it to another country; and
- how long we store it for;
- whether we do automated decision-making or profiling.

2. The purposes we are processing your information for and why we are lawfully able to do this

There are therefore defined processing conditions that allow the use of this and those applicable to the use of this information by QLog are set out below.

Under data protection law the following lawful bases apply to the processing of personal data:

- Article 6(1)(f) – ‘processing is necessary for the purposes of the legitimate interests pursued by the controller...’
 - For processing of personal data under a commercial contract for commercial purposes.
 - For performance monitoring and analysis purposes.

3. Source and recipients of personal data

QLog collects personal data directly from our clients (e.g. hospitals) and our suppliers.

We will not ordinarily or routinely share any of your personal data with any third-party unless we have a lawful reason for doing so.

We may share aggregated (anonymised) data with our commercial partners in support of the service.

4. Keeping your data secure

We will use a combination of technical and organisational measures to safeguard our clients personal data retained within the QLog System..

5. International Standards

We store our client personal data in accordance with national and regional regulatory data protection legislation.

6. Retention

We retain your personal data in accordance with national and regional retention guidelines for as long as is necessary to provide our services to our clients.

Where we anonymise personal data (so that it can no longer be associated with you) for research or statistical purposes, we may use this information indefinitely without further notice to you.

7. Automated decision-making or profiling

We do not undertake any automated decision-making or profiling in relation to clients personal data.

8. Your Rights

If you are a client of QLog, under data protection law, you have the following rights to your information:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.
